



In doing so it focuses on a specific institutional, epistemic and local context, while looking at it through the lens of international debates.





Card-based Discussion Method: "RESPONSE_ABILITY"

- We developed RESPONSE_ABILITY as a response to major challenges we face when discussing issues of research integrity and ethics.
 - Often these issues are **not spoken about openly** in everyday academic life
 - It should offer a room for collective reflection across disciplinary boundaries
 - No classical 'teaching format' (where we know and you learn) but horizontal engagement, where you bring your own experiences to the table
- Research practices are constantly changing research ethics and integrity can therefore not be seen as a rule-following exercise, but researchers have to develop the skills to reflect on new challenges and learn to ask the 'right' questions. ->"RESPONSE_ABILITY"
